PUPPY SALES APPLICATION/AGREEMENT CONTRACT

PURCHASER AGREES TO THE FOLLOWING CONDITIONS:

The Doberman is a purebred Doberman Pinscher. The litter is registered with the American Kennel Club and individual registration form will be furnished to the buyer after the breeder has received payment in full.

To the best of the breeder's knowledge, this Doberman is free of communicable diseases and at time of sell the Doberman is in excellent health. The Doberman has received appropriate medical inoculations and care.

No one can Guarantee Genetics, but the breeder guarantees that if your Doberman should die prematurely (before the age of 1 year) from a genetically caused problem, the buyer must notify seller immediately. A written statement as to the genetic defect must be provided to us from buyer's licensed pathologist veterinarian. A written second opinion from the breeder's licensed pathologist veterinarian must be provided. Seller/Breeder will reserve the right to have the autopsy performed by a licensed pathologist veterinarian to determine that genetics was the factor in the puppy's death. If genetics is the factor, then, Seller/Breeder will refund (minus deposit) the price of the puppy. Buyer is responsible for all veterinarian & autopsy bills.

The buyer agrees to have the dog examined by your veterinarian at your expense within 3 days from date of purchase to validate this health agreement. If the veterinarian does not give the dog a clean bill of health, buyer must notify the seller immediately. Seller reserves the right to have the dog re-examined by our veterinarian at our cost. **ANY CONDITION THAT IS MINOR, CORRECTABLE OR A BREED RELATED MINOR CONDITION IS NOT COVERED AND NO CONDITION WHICH COULD GO AWAY, OR IS CONSIDERED TO BE A CONDITION WHICH A PUPPY WILL LIKELY GROW OUT OF IS NOT COVERED.**

Seller/Breeder does not guarantee against Parvo, Corona Virus or any type of intestinal viruses or bacterial including Coccidiosis, Giardia once the puppy leaves breeder's possession. Seller/Breeder has provided all **DNA** health testing on all breeding dogs for **DCM, VWD, DM, HIP X-RAYS**.

Further is Doberman has been bred to the breed standard and for healthy, sound, loving temperament, which should also be naturally protective of his family and home. No guarantee is made as to disposition, conformation, or breeding ability.

Further, Breeder strongly recommends that Buyer enter and complete as least two, basic obedience classes with the Doberman and provide proper socialization opportunities for the Doberman.
